



### 1 – The Organization

The WSK Promotion Ltd (73024 Maglie LE – Piazza della Repubblica, 8 website: [www.wskarting.com](http://www.wskarting.com) e-mail: [info@wskarting.com](mailto:info@wskarting.com)), holder of a N.326620 CSAI karting licence as Organizer, organises and calls the “2025 WSK Official Collective Test” (“WSK O.C.T.”).

For the international categories (KZ2, OK, OKJ), all Drivers, Entrants and Officials participating undertake, on behalf of themselves, their employees, to observe all the provisions of the International Sporting Code («the Code»), the FIA KARTING Technical Regulations and these Sporting Regulations of 2025 WSK O.C.T.

For the national categories (Mini GR3, OKNJ), all Drivers, Entrants and Officials participating undertake, on behalf of themselves their employees, to observe all the provisions of the National Sporting Code, the FIA KARTING Technical Regulations for the category Mini GR3 and the ACI Technical Regulations for the category OKNJ and the Sporting Regulations of 2025 WSK O.C.T.

### 2 – Calendar

### 3 – Categories admitted:

**3.1** The following international categories will be admitted:

- a) OK
- b) OKJ
- c) KZ2

Karts must comply with the FIA KARTING Technical Regulations.

**3.2** The following national categories will be admitted:

- a) Mini U10 GR3 (8-10 years old) **born from 01/01/2015**
- b) Mini GR3 (11-12 years old)

The karts must comply with the FIA KARTING Technical Regulations.

- c) OKNJ

Karts must comply with the ACI KARTING Technical Regulations.

### 4 – Entries: **(Reserved exclusively for drivers registered for the first round of the WSK Super Master Series)**

Participation in the **2025 WSK O.C.T.**” is restricted to Entrants who will send their entries, through the relevant form provided, by **January 13, 2025**.

All Entrants must hold Entrant Licences.

For the international categories, all Drivers must hold International Driver Licences.

The International Driver Licence grades required per category are as follows:

- OKJ: International G
- OK: International F or E
- KZ2: International E

**Mini GR3: All drivers must have a National Mini license or National license of their country or International license G. Foreign drivers participating with a National license of their country or drivers participating with an International license G must not be 13 years old.**

**OKNJ: National License or International License G.**

The registrations must be delivered to **WSK Promotion Ltd** - e-mail: [info@wskarting.com](mailto:info@wskarting.com)) as written on the relevant forms and together with **Euro 380,00 valid for 4 days**.

In addition to that, it is also possible for each category to register to the single test day of 2025 WSK O.C.T. until to the attainment of the maximum number of the admitted Drivers. These must reach **WSK Promotion Ltd** together with **Euro 120,00** registration fee.



Not concurring in one or more days gives no right to any reimbursement of the registration fees, whether **partial or full.**

## **5 – Equipment**

The Drivers can use the following material:

- a) Chassis: specified by the Entrants on their registration.
- b) Engines: specified by the Entrants on their registration.
- c) Tyres:

### **c.1.1) OK – OKJ – KZ2**

CIK FIA homologated tyres.

- SLICK: **OK LCONT LPM PRIME - RAIN: LCONT LWR**
- SLICK: **OKJ VEGA XH4 CIK-FIA OPTION - RAIN: VEGA W6 CIK-FIA**
- SLICK: **KZ2 VEGA XM4 CIK-FIA PRIME RAIN: VEGA W6 CIK-FIA**

### **c.2.1) Mini GR3 – OKNJ CIK FIA homologated tyres.**

- SLICK: **Mini VEGA M1 CIK-FIA RAIN: VEGA WM1 CIK-FIA**
- SLICK: **OKNJ VEGA XH4 CIK-FIA OPTION - RAIN: VEGA W6 CIK-FIA**

- d) **A personal transponder is mandatory and only MyLaps transponders are allowed (TR2 Mylaps Kart, TranX2 Karting Transponder, TranX3 Karting Transponder and X2 Karting Transponder). It is the Entrant's / Driver's responsibility to ensure the transponder is fully functional and battery charged at all times. The Transponder can be rented from the organizer at a cost of €20.00 for the entire duration of the test.**

## **6 - Gasoline**

The gasoline (**KART RON102**) will be given on the track with 25 lt containers by **PANTA SPA.**

## **7 - Maximum number of karts on the track**

- a) No more than 45 karts will be allowed on the track during these practices.
